Data from each available state is provided either by the State Police or the Administrative Office of Courts.

A Statewide search does not preclude the possibility of a criminal record at a local or county court. Statewide reports may reflect arrest / charge information only which may not be considered in hiring decisions. A County Criminal Record Search in the county of record may be required to obtain disposition information. Reporting policies vary from state to state. Statewide records may not always contain complete information.



Alabama

Felony and misdemeanor arrests and convictions from the Alabama Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 2 - 3 Business Days



Arkansas

Felony and state-level misdemeanor arrests and convictions from the Arkansas Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 2 - 3 Business Days



Arizona

Felonies and most state-level misdemeanors from the Arizona Administrative Office of Courts. Records include defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence. **SEE NOTE BELOW.**

TURN-AROUND TIME: 1 - 2 Business Days



Colorado

Criminal & traffic court records from the official repository of the Colorado Judicial Branch from District and County Courts. Results show the defendant's name, arresting agency, arrest or filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 1 - 2 Business Days



Connecticut

Felony & misdemeanor records from the Connecticut Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 1 - 2 Business Days



Delaware

Statewide felony and misdemeanor records from the Delaware State Police. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 2 - 3 Business Days



Florida

Statewide arrests and convictions from the Florida Department of Law Enforcement. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.

TURN-AROUND TIME: 1 - 2 Business Days



Georgia

Statewide criminal arrests and convictions from the Georgia Bureau of Investigation. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence. **Requires a Release of Information Form for Misdemeanor Search. Felony only without a Release Form.**

TURN-AROUND TIME: 1 - 2 Business Days



Hawaii

Statewide felony and misdemeanor records from the Hawaii Criminal Justice Data Center. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), arresting agency, court and case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Idaho

Felony and misdemeanor conviction records from the Records Division / Idaho State Police. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 3 - 4 Business Days



Illinois

Felony & misdemeanor criminal records from the Bureau of Identification / Illinois State Police. Results show the defendant's name, arresting agency, arrest date, charge(s), case #, disposition if reported by Court, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 1 - 2 Business Days



Indiana

Felony and misdemeanor arrest and conviction records from the Central Records Division / Indiana State Police. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Kentucky

Felonies and most state-level misdemeanors from the Kentucky Administrative Office of Courts. Records include defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Maryland

Statewide **misdemeanor-only** Court records from Maryland's District Courts. Results show the defendant's name, arrest or file date, charge(s), case #, disposition, disposition date and sentence. This search does **not** include Circuit Courts (Felony Dispositions). Felony dispositions available only with County Criminal Record Search. TURN-AROUND TIME: 1 - 2 Business Days



Michigan

Felony and misdemeanor arrests and convictions from the Michigan State Police. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Minnesota

Felony and misdemeanor records from the Minnesota Bureau of Criminal Apprehension. Includes felonies and gross misdemeanors of persons sentenced to jail time, probation or paroled. Results show the defendant's name, arresting agency, file date, charge(s), case #, disposition, disposition date and sentence. TURN-AROUND TIME: 1 - 2 Business Days



Missouri

Statewide felony and misdemeanor records from the Criminal Records Division of the Missouri Highway Patrol. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 3 - 4 Business Days



Mississippi

Felony & state-level misdemeanors from the Mississippi Highway Patrol. Results show the defendant's name, arrest or file date, charge(s), court case #, court disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



Montana

Felony & misdemeanor records from the Criminal Records Division, Montana Department of Justice. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



N. Carolina

Felony and misdemeanor records from the North Carolina Administrative Office of Courts. Results show the defendant's name, arrest or court filing date, charge(s), county, court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



N. Dakota

Felony & misdemeanor convictions from the North Dakota Bureau of Criminal Investigation. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



New Hampshire

Felony & misdemeanor convictions from the Criminal Records Division / New Hampshire State Police. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



New Jersey

Statewide misdemeanor and felony convictions from the New Jersey Administrative Office of Courts. Results show the defendant's name, arrest or court filing date, charge(s), court & case #, court disposition, disposition date and sentence if reported to this agency.
TURN-AROUND TIME: 1 - 2 Business Days



New Mexico

Felony & misdemeanor convictions from the Criminal Records Division / New Mexico Department of Public Safety. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



Nevada

Statewide felony and misdemeanor convictions from the Records & I.D. Section / Nevada Highway Patrol. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 3 - 4 Business Days



New York

Statewide misdemeanor and felony convictions from the New York Administrative Office of Courts. Results show the defendant's name, arrest or court filing date, court from which case originated, charge(s), court & case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Ohio

Felony & misdemeanor arrest and conviction records from the databases of the statewide sheriff's association, the Ohio Prosecuting Attorney's Association and the Department of Corrections. Results show the defendant's name, arrest or file date, charge(s), county, case #, disposition, disposition date and sentence. TURN-AROUND TIME: 1 - 2 Business Days



Oklahoma

Felony & misdemeanor convictions from the Criminal History Reporting Section / Oklahoma State Bureau of Investigation. Records show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



Oregon

Felony & misdemeanor records as from the Identification Services Section / Oregon State Police. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days



Pennsylvania

Felony and misdemeanor convictions from the Pennsylvania State Police. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days - **SEE NOTE BELOW.**



Rhode Island

Felony & misdemeanor records from the Rhode Island Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 1 - 2 Business Days



S. Carolina

Felony and misdemeanor records from the South Carolina Law Enforcement Division (S.L.E.D.). Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



S. Dakota

Felony and misdemeanor convictions from the South Dakota Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or court filing date, charge(s), court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 3 - 4 Business Days



Tennessee

Felony convictions since 1990 and misdemeanor dispositions since 1995 from the Tennessee Administrative Office of Courts. Include indictments, pre-trial diversions, acquittals, pleas and dismissals. Includes date, county, case #, defendant name, DOB, SSN (when available), charges, dispositions / judgments and sentence. TURN-AROUND TIME: 1 - 2 Business Days



Texas

Felony and state-level misdemeanor convictions from the Texas Department of Public Safety. Search results include arrest or court filing date, county, case #, defendant name, DOB, arresting agency, charges, dispositions/judgments and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Virginia

Felony & misdemeanor records from Virginia's General District and Superior Courts. This search does **not** include Fairfax, Price William, Alexandria, Essex or Surry Circuit Courts. Results show the defendant's name, arrest or court filing date, charge(s), county & case #, disposition, disposition date and sentence. TURN-AROUND TIME: 1 - 2 Business Days - **SEE NOTE BELOW.**



Washington

Felony, misdemeanor and traffic records from the Washington Administrative Office of Courts. Results show the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 2 - 3 Business Days



Wisconsin

Felony and misdemeanor records from the Wisconsin Administrative Office of Courts. Results include the defendant's name, arresting agency, arrest or court filing date, charge(s), county & court case #, court disposition, disposition date and sentence.
TURN-AROUND TIME: 1 - 2 Business Days



Wyoming

Felony & misdemeanor convictions from the Central Records Unit / Wyoming Division of Criminal Investigation. Results include the defendant's name, arresting agency, arrest or file date, charge(s), case #, disposition, disposition date and sentence. **Requires a Release of Information Form.**
TURN-AROUND TIME: 3 - 4 Business Days

Arizona

The Statewide Arizona Criminal Search does not include the following Counties / Courts:

Maricopa / Superior Court, Justice of the Peace Courts

Municipal Courts in Chandler, Gilbert, Mesa, Paradise Valley, Phoenix or Tempe

Mohave / Superior Court, Justice of the Peace Courts in:

Kingman, Bullhead City, Lake Havasu, or Colorado City

Municipal Courts in Kingman, Bullhead City, Lake Havasu or Colorado City

Pima / Superior Court, Pima Consolidate Justice Courts

Yavapai / Prescott Municipal Court, Prescott Justice of the Peace Courts

Pennsylvania

The Pennsylvania State Police may place a request for a criminal background check "Under Review." A "Request Under Review" does not necessarily mean that the subject of your search has a criminal record. A request may be placed "Under Review" for several reasons. If a criminal record exist, the information must be verified by the Pennsylvania State Police with the Court in which the case was filed. Results from a "Request Under Review" may take from 14 to 28 days to complete. Fairfield Information Services & Associates has no control over the Pennsylvania State Police review process and cannot guarantee results in our normal 24 - 72 hour turn-around time.

Virginia

The Virginia Administrative Office of Courts has removed defendant's Social Security Numbers. Search results are based upon name and date of birth. This search does not include Fairfax, Price William, Alexandria, Essex or Surry Circuit Courts. These Counties require a County Criminal Record Search.
